Report on the audit of consolidated financial statements

Our opinion

In our opinion, the attached annual consolidated financial statements:

- give a true and fair view of the consolidated financial position of the group Wirtualna Polska Holding S.A. (the "Group"), in which Wirtualna Polska Holding S.A. is the parent entity (the "Parent Company") as at 31 December 2020 and the Group's consolidated financial performance and the consolidated cash flows for the year then ended in accordance with the applicable International Financial Reporting Standards as adopted by the European Union and the adopted accounting policies;
- comply in terms of form and content with the laws applicable to the Group and the Parent Company's Articles of Association;

Our opinion is consistent with our additional report to the Audit Committee issued on the date of this report.

What we have audited

We have audited the annual consolidated financial statements of the Group Wirtualna Polska Holding S.A. which comprise:

- the consolidated statement of financial position as at 31 December 2020;
- and the following prepared for the financial year from 1 January to 31 December 2020:
- the consolidated statement of profit or loss and other comprehensive income;
 - the consolidated statement of changes in equity;
 - the consolidated statement of cash flows, and
 - additional information containing adopted accounting policies and other explanatory information.

Basis for opinion

Basis for opinion

We conducted our audit in accordance with the National Standards on Auditing in the wording of the International Standards on Auditing as adopted by the resolution of the National Council of Statutory Auditors (“NSA”) and pursuant to the Law of 11 May 2017 on Registered Auditors, Registered Audit Companies and Public Oversight (the “Law on Registered Auditors” – Journal of Laws of 2020, item 1415) and the Regulation (EU) No. 537/2014 of 16 April 2014 on specific requirements regarding the statutory audit of public-interest entities (the “EU Regulation” – Journal of Laws EU L158). Our responsibilities under NSA are further described in the Auditor’s responsibilities for the audit of the consolidated financial statements section of our report.

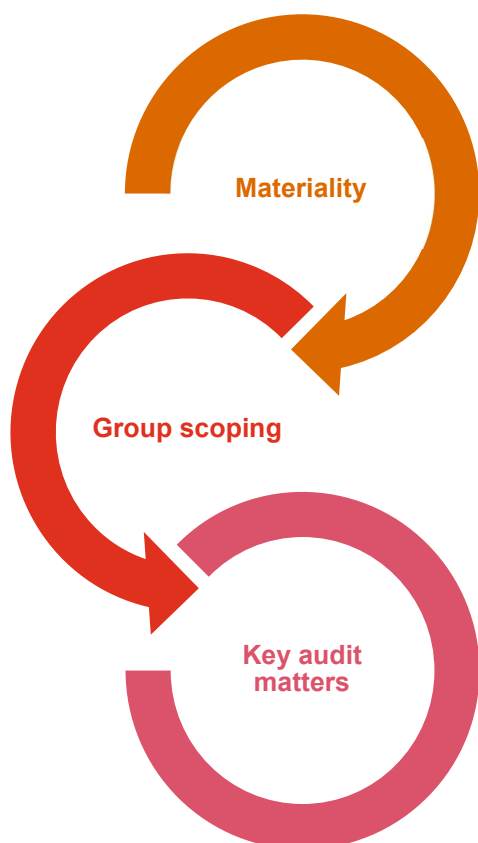
We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Independence

We are independent of the Group in accordance with the International Code of Ethics for Professional Accountants (including International Independence Standards) issued by the International Ethics Standards Board for Accountants (IESBA Code) as adopted by resolution of the National Council of Statutory Auditors and other ethical requirements that are relevant to our audit of the financial statements in Poland. We have fulfilled our other ethical responsibilities in accordance with these requirements and the IESBA Code. During the audit, the key registered auditor and the registered audit firm remained independent of the Group in accordance with the independence requirements set out in the Act on Registered Auditors and in the EU Regulation.

Our audit approach

Overview



- The overall materiality threshold adopted for the purposes of our audit was set at PLN 5 060 thousand, which represents 2,5% of EBITDA as determined during the planning phase.
- We have audited the Parent Company and 3 subsidiaries in Poland ((Wirtualna Polska Media S.A., Domodi Sp. z o.o., Wakacje.pl S.A.) and performed selected audit activities on the remaining entities from the Group (Totalmoney Sp. z o.o., Businessclick Sp. z o.o., Nocowanie.pl Sp. z o.o., Netwizor Sp.z o.o., Grupa eHoliday.pl Sp. z o.o., WPZ Sp. z o. o., Extradom.pl Sp. z o. o., Superauto24.com Sp. z o. o., Parklot Sp. z o. o., Open FM Sp. z o.o.).
- The audit team visited the following subsidiaries Wirtualna Polska Media S.A., Domodi Sp. z o.o., Wakacje.pl S.A.
- The scope of our audit covered 91% of the Group’s revenue and 87% of consolidated EBITDA
- Recoverability of a deferred income tax asset and the existence of inherent uncertainties over income tax settlements
- Impairment of goodwill
- Valuation of the liability in respect of call options for non-controlling shares in Nocowanie.pl



As part of designing our audit, we determined materiality and assessed the risks of material misstatement in the consolidated financial statements. In particular, we considered where the Parent Company's Management Board made subjective judgements; for example, in respect of significant accounting estimates that involved making assumptions and considering future events that are inherently uncertain. As in all of our audits we also addressed the risk of management override of internal controls, including among other matters, consideration of whether there was evidence of bias that represented a risk of material misstatement due to fraud.

We tailored the scope of our audit in order to perform sufficient work to enable us to provide an opinion on the consolidated financial statements as a whole, taking into account the structure of the Group, the accounting processes and controls, and the industry in which the Group operated.

Materiality

The scope of our audit was influenced by our application of materiality. An audit is designed to obtain reasonable assurance whether the consolidated financial statements are free from material misstatement. Misstatements may arise due to fraud or error. They are considered material if, individually or in aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of the consolidated financial statements.

Based on our professional judgement, we determined certain quantitative thresholds for materiality, including the overall materiality for the consolidated financial statements as a whole presented below. These, together with qualitative considerations, helped us to determine the scope of our audit and the nature, timing and extent of our audit procedures and to evaluate the effect of misstatements, if any, both individually and in aggregate on the consolidated financial statements as a whole.

How we determined it	2.5% of EBITDA as determined during planning phase. We reviewed the materiality assessment during the audit, and found no indicators that would require its reassessment, due to immaterial impact on the audit plan. This measure is an alternative measure to assess the financial performance and has been defined by the Company in note 11 in the consolidated financial statement. The Company's board is responsible for defining and establishing EBITDA, and its calculation may vary between entities.

Rationale for the materiality benchmark applied	We have adopted EBITDA as the basis for determining materiality because, in our opinion, it is an indicator commonly used by the users of financial statements to evaluate the Group's operations and is a generally adopted benchmark. We adopted the materiality threshold at 2.5% because based on our professional judgement it is within the quantitative materiality thresholds acceptable by the auditing standards.

We agreed with the Audit Committee that we would report to them misstatements identified during our audit above PLN 250 thousand, as well

as misstatements below that amount that, in our view, warranted reporting for qualitative reasons.

Key audit matters

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. They include the most significant identified risks of material misstatements, including the identified risks of material

misstatement resulting from fraud. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon. We do not provide a separate opinion on these matters.

Key audit matter	How our audit addressed the key audit matter
<p>Recoverability of a deferred income tax asset and the existence of inherent uncertainties over income tax settlements</p> <p>As at the balance sheet date, the Group recognized a deferred income tax asset of PLN 39,6 million, including PLN 11,5 million relating to tax losses carried forward. In addition in the audited year and previous years, the Group used tax losses in the amount of PLN 65,2 million arising from the sale of shares in a subsidiary. In the audited year, the Group received the results of tax audit carried out by the tax authorities regarding this transaction. Disclosures regarding the deferred tax asset are presented in the Note 34 to the financial statements, and the accounting policies and audit results – in the Note 2 and 4.</p> <p>We paid special attention to analysing the correctness of the recognition of the deferred income tax asset and the recognition of any adjustments to this asset or recognition of deferred tax liabilities related to significant uncertainty regarding income tax settlements due to the fact that the Management Board needs to make material assumptions and judgements. These concern, in particular, to the correct interpretation of applicable tax regulations, assessment of likelihood of final questioning of the interpretation of tax regulations adopted by the Company by the tax authorities, the determination of the tax bases of the individual assets and liabilities, an evaluation of the timing and manner of their settlement, and the probability that future taxable profits will be available, from which tax benefits could be deducted. As disclosed in Note 4 and 19 in assessing the recoverability of a deferred income tax asset and the inherent uncertainties over income tax, the Management Board took into account the provisions of the General Anti-Abuse Rule. Given the inherent risk of uncertainties over the material estimates made by the Management Board, we have concluded that this is a key matter for our audit.

Impairment of goodwill

In the Group's financial statements, as at the balance sheet date the goodwill balance amounts to PLN 364.3 million and is material to the financial statements (29% of balance sheet total). The goodwill is described in Note 23 to the financial statements and the relevant accounting policies – in Note 2 to the financial statements.

According to IFRSs, the Management Board tests the goodwill allocated to a cash-generating unit for impairment at least at the end of each financial year, by calculating the recoverable amount using the value-in-use approach.

Conducting an impairment test involves the need to make a number of material assumptions and judgements concerning, among other things, the adopted strategy of the cash-generating unit to which the goodwill has been allocated, financial plans and cash flow forecasts for the following years, including after the period covered by detailed forecasts, as well as macroeconomic and market assumptions.

As a result of the impairment tests conducted, no impairment was recognized for the goodwill in the financial statements.

Given the inherent risk of uncertainties over the material estimates made by the Management Board, we have concluded that this is a key matter for our audit.

Valuation of the liability in respect of call options for non-controlling shares in Nocowanie.pl

The value of the liability in respect of issued call options for non-controlling shares in Nocowanie.pl, recognized in the Group's financial statements, amounts to PLN 16,6 million as at the balance sheet date. The liabilities in respect of the options are described in Note 37 to the financial statements, and the relevant accounting policies – in Note 2.

Our audit procedures covered, in particular:

- gaining an understanding of and evaluating the process of estimating impairment for goodwill and the principles for determining cash-generating units;
- analysing the impairment test performed by the Management Board, in particular:
 - (a) a critical assessment of the assumptions and estimates made by the Company's Management Board, used to determine the recoverable amount (a five-year forecast period for future cash flows and the revenue and operating margin levels, the discount rate used, the annual growth rate in residual period);
 - (b) verifying the arithmetical correctness and methodological consistency of the valuation model based on discounted cash flows, using PwC in-house valuation specialists;
- evaluating the Management Board's analysis of the sensitivity of the assumptions made on the results of the impairment assessment;
- evaluating the correctness and completeness of the disclosures as regards impairment tests in the consolidated financial statements.

Our audit procedures covered, in particular:

- gaining an understanding of the model used to measure the liability and verifying its compliance with the provisions of the relevant agreements;
 - analysing the valuation performed by the Management Board, in particular:
 - (a) an independent assessment of the assumptions made by the Company's Management Board, concerning the companies' future results of operations (among other things, EBITDA, revenue)

As part of the acquisition of 75% of shares in Nocowanie.pl in the previous years the parties to the transaction granted each other options to purchase/sell the remaining 25% of shares, which were still held by the original shareholders. The liability in respect of the options was initially recognized in correspondence with the equity attributable to equity holders of the parent, whereas following the initial recognition it is measured at amortized cost and changes in the estimated redemption amount are recognized in profit and loss, whereas cost of interest is recognized in financial costs.

During the audited period, the Group due to realisation of the first tranche, purchased some of the minority shares in Nocowanie.pl Sp. z o. o. representing 10% of the share capital of this company. The selling price for all acquired shares totalled PLN 13,467 thousand. As a result of the transaction, the Group holds 85% of shares in Nocowanie.pl as at the balance sheet date.

The value of the liability in respect of the options is affected by the EBITDA level and the revenue level which are estimated by the Management Board.

As at the balance sheet date, the Management Board estimated the expected future cash flows from the exercise of the options, as part of which it updated several material assumptions made in the previous year, concerning the companies' results of operations in the future.

Given the inherent risk of uncertainties over the material estimates made by the Management Board, we have concluded that this is a key matter for our audit.

and an estimation of the originally adopted discount rate;

- (b) verifying the arithmetical correctness and methodological consistency of the valuation model, using PwC in-house valuation specialists, and verifying its compliance with the provisions of the relevant agreements;
- evaluating the Management Board's analysis of the sensitivity of the assumptions made to the value of the liability;
- evaluating the correctness and completeness of the disclosures as regards liability in respect of the options.

Responsibility of the Management and Supervisory Board for the consolidated financial statements

The Management Board of the Parent Company is responsible for the preparation of the annual consolidated financial statements that give a true and fair view of the Group's financial position and results of operations, in accordance with International Financial Reporting Standards as adopted by the European Union, the adopted accounting policies, the applicable laws and the Parent Company's Articles of Association, and for such internal control as the Management Board determines is necessary to enable the preparation of consolidated financial statements that are free

from material misstatement, whether due to fraud or error.

In preparing the consolidated financial statements, the Parent Company's Management Board is responsible for assessing the Company's Group's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Management Board either intends to liquidate the Group or to cease operations, or has no realistic alternative but to do so.



The Parent Company's Management Board are obliged to ensure that the consolidated financial statements comply with the requirements specified in the Accounting Act of 29 September 1994 ("the

Accounting Law" – Consolidated text: Journal of Laws of 2021, item 217, as amended). Members of the Supervisory Board are responsible for overseeing the financial reporting process.

Auditor's responsibility for the audit of the consolidated financial statements

Our objectives are to obtain reasonable assurance about whether the consolidated financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with the NSA will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in aggregate, they could reasonably be expected to influence economic decisions of users taken on the basis of these consolidated financial statements.

The scope of the audit does not include an assurance on the Group's future profitability nor the efficiency and effectiveness of the Parent Company's Management Board conducting its affairs, now or in future.

As part of an audit in accordance with NSA, we exercise professional judgement and maintain professional scepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the consolidated financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Group's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by the Parent Company's Management Board.

- Conclude on the appropriateness of the Parent Company's Management Board's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Group's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the consolidated financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Company Group to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the consolidated financial statements, including the disclosures, and whether the consolidated financial statements represent the underlying transactions and events in a manner that achieves fair presentation.
- Obtain sufficient appropriate audit evidence regarding the financial information of the entities or business activities within the Group to express an opinion on the consolidated financial statements. We are responsible for the direction, supervision and performance of the Group audit. We remain solely responsible for our audit opinion.

We communicate with the Audit Committee regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide the Audit Committee with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, actions taken to eliminate threats or safeguards applied.

From the matters communicated to the Audit Committee, we determine those matters that were



of most significance in the audit of the consolidated financial statements of the current period and are therefore the key audit matters. We describe these matters in our auditor's report unless law or regulation precludes public disclosure about the matter or when, in extremely rare circumstances,

we determine that a matter should not be communicated in our report because the adverse consequences of doing so would reasonably be expected to outweigh the public interest benefits of such communication.

Other information, including the Report on the operations

Other information

Other information comprises a Report on the Group's operations for the financial year ended 31 December 2020 ("the Combined report on the operations") and the corporate governance statement and the statement on non-financial information referred to in Article 55(2b) of the Accounting Act which are a separate parts of the Combined report on the operations, together "Other Information"). Other information does not include the financial statements and our auditor's report thereon.

Responsibility of the Management and Supervisory Board

The Management Board of the Parent Company is responsible for the preparation of the Other Information in accordance with the law.

The Parent Company's Management Board and the members of the Supervisory Board are obliged to ensure that the Combined Report on the Group's operations including its separate parts complies with the requirements of the Accounting Law.

Registered auditor's responsibility

Our opinion on the consolidated financial statements does not cover the Other Information.

In connection with our audit of the consolidated financial statements, our responsibility is to read the Other Information and, in doing so, consider whether the Other Information is materially inconsistent with the information in the consolidated financial statements, our knowledge obtained in our audit, or otherwise appears to be materially misstated. If, based on the work performed, we identified a material misstatement in the Other Information, we are obliged to inform about it in our audit report. In accordance with the requirements of the Law on the Registered Auditors, we are also obliged to issue an opinion on whether the Report on the operations has been prepared in accordance with the law and is consistent with information included in annual consolidated financial statements.

Moreover, we are obliged to issue an opinion on whether the Parent Company provided the required information in its corporate governance statement and to inform whether the Parent Company prepared a statement on non-financial information.

Opinion on the Combined report on the operations

Based on the work we carried out during our audit, in our opinion, the Combined report on the Company's Group's operations:

- has been prepared in accordance with the requirements of Article 49 of the Accounting Act and para. 71 of the Regulation of the Minister of Finance dated 29 March 2018 on current and periodical information submitted by issuers of securities and conditions for considering as equivalent the information required under the legislation of a non-Member State ("Regulation on current information" – Journal of Laws 2018, item 757),
- is consistent with the information in the consolidated financial statements.

Moreover, based on the knowledge of the Group and its environment obtained during our audit, we have not identified any material misstatements in the Combined report on the Group's operations.

Opinion on the corporate governance statement

In our opinion, in its corporate governance statement, the Group included information set out in para. 70.6 (5) of the Regulation on current information. In addition, in our opinion, information specified in paragraph 70.6 (5)(c)–(f), (h) and (i) of the said Regulation included in the corporate governance statement are consistent with the applicable provisions of the law and with information included in the consolidated financial statements.



Information on non-financial information

In accordance with the requirements of the Act on the Registered Auditors, we confirm that the Group has prepared a statement on non-financial information referred to in Article 55(2b) of the

Accounting Act as a separate section of the Report on the operations.

We have not performed any assurance work relating to the statement on non-financial information and we do not provide any assurance with regard to it.

Report on other legal and regulatory requirements

Report on the compliance of the format of the consolidated financial statements with the requirements of the Single European Electronic Format ("ESEF")

We have been engaged by the Management Board of the Parent Company under the contract for the audit of the consolidated financial statements for an attestation service providing reasonable assurance in the scope of verification of compliance with the applicable requirements of the electronic reporting format of the Group's consolidated financial statements for the year ended 31 December 2020, included in the accompanying annual report 2020 ("Electronic reporting format for the consolidated financial statements").

Description of the subject of the engagement and applicable criteria

The electronic format of reporting the consolidated financial statements was used by the Management Board of the Parent Company in order to meet the requirements of Art. 3 and 4 of Regulation (EU) 2019/815 of 17 December 2018 supplementing Directive 2004/109 / EC of the European Parliament and of the Council with regard to regulatory technical standards concerning the specification of a single electronic reporting format ("ESEF Regulation"). The applicable requirements for the electronic reporting format of consolidated financial statements are contained in the ESEF Regulation.

The requirements described in the preceding sentence define the basis for the use of the Electronic Reporting Format for Consolidated Financial Statements and, in our opinion, constitute appropriate criteria for the formulation of a conclusion providing reasonable assurance.

Responsibility of the Management Board of the Parent Company and the Supervisory Board

The Management Board of the Company is responsible for the use of the electronic reporting format for the consolidated financial statements, which complies with the requirements of the ESEF Regulation. This responsibility includes the selection and application of appropriate iXBRL

markings using the ESEF taxonomy and the design, implementation and maintenance of an internal control system suitable for the preparation of the Electronic Reporting Format for Consolidated Financial Statements, which does not contain material non-compliance with the requirements of the ESEF Regulation.

Members of the Supervisory Board are responsible for control the financial reporting process, which should also be understood as the preparation of financial statements in accordance with the format resulting from the ESEF Regulation.

Responsibility of the statutory auditor

Our role was to make a conclusion providing reasonable assurance that the electronic reporting format of the consolidated financial statements complies, in all material respects, with the ESEF Regulation.

We performed our service in accordance with the National Standard on Assurance Services Other than Audit and Review 3000 (Z) in the wording of the International Standard on Assurance Services 3000 (amended) - "Assurance services other than audits and reviews of historical financial information" issued by the National Council of Statutory Auditors (KSUA 3000 (WITH)). This standard requires us to comply with ethical requirements, plan and perform procedures to obtain reasonable assurance that the electronic format of reporting the consolidated financial statements has been applied, in all material respects, in accordance with the applicable requirements.

Reasonable assurance is a high level of assurance, but it is not guarantee that the service performed in accordance with KSUA 3000 (Z) will always detect the existing material misstatement (material non-compliance).

Quality control requirements

We apply the provisions of the resolution of the National Council of Statutory Auditors on the principles of internal quality control in the wording of the International Standard on Quality Control 1



(IAASB) and in accordance with it, we maintain a comprehensive quality control system including documented policies and procedures regarding compliance with ethical requirements, professional standards and applicable requirements legal and regulatory.

We comply with the independence and other ethical requirements of the International Code of Ethics for Professional Accountants (including the International Standards of Independence) issued by the International Ethical Standards Board for Accountants and adopted by resolution of the National Council of Statutory Auditors, which is based on the fundamental principles of honesty, objectivity, professional competence and due diligence, confidentiality and professional conduct.

Summary of the work performed

The procedures planned and performed by us were aimed at obtaining reasonable assurance whether the electronic format of reporting the consolidated financial statements was applied, in all material respects, in accordance with the applicable requirements and did not contain any material errors or omissions. Our procedures mainly consist of:

- understanding of the internal control system and processes appropriate for the use of the Electronic Reporting Format for Consolidated Financial Statements, including the use of XHTML and the labelling of the consolidated financial statements;
- verification of the correctness of the application of the XHTML format;
- assessment of the completeness of the labeling of the consolidated financial statements using the iXBRL tags in accordance with the requirements for the implementation of the electronic format described in the ESEF Regulation;
- assessing the appropriateness of the Group's use of XBRL tags selected from

the ESEF taxonomy and the creation of extension tags where no relevant element has been identified in the ESEF taxonomy;

- assessment of the correctness of anchoring the applied taxonomy extensions in the basic taxonomy specified in the ESEF Regulation.

We believe that the evidence we have obtained is sufficient and appropriate to support our conclusion.

Conclusions
